#### ANNOUNCEMENTS & INFORMATION

Kameon Smith - Introduction of Chelan County Superior Court Judge Bob McSeveney Councilor Smith introduced Judge Bob McSeveney to the Mayor and City Council. Judge McSeveney stated that he was appointed to the Chelan County Superior Court in January. He is visiting City Councils in the area to introduce himself and provide them a little of his background. He shared his qualifications and previous experience that brought him to Superior Court.

#### Report from legal counsel on 107 Mt. Cashmere Place construction site

City Attorney Chuck Zimmerman reported his findings regarding investigation of the complaints regarding the construction site at 107 Mt. Cashmere Place. Brock Laughlin of Blades Code Services also visited the site. Neither the City Attorney Chuck Zimmerman nor Inspector Brock Laughlin were able to identify any City municipal code or building code violations associated with the current status of the site.

#### PUBLIC COMMENT PERIOD - For Items Not on the Agenda

Patricia Ommen, residing at 4864 Rank Road, voiced concerns regarding the construction site at 107 Mt. Cashmere Place. City Attorney Chuck Zimmerman addressed her concerns and provided her with facts regarding city codes and building code regulations and requirements.

Mayor Gomes added Item No. 3 - 2018 Road Pavement Preservation project options.

MOVED by Councilor Erickson and seconded by Councilor Scott to approve the agenda as amended. Motion carried.

MOVED by Councilor Fletcher and seconded by Councilor Smith to approve the consent agenda as presented. Motion carried.

JOINT CASHMERE CITY COUNCIL AND CASHMERE PLANNING COMMISSION MEETING

Director Botello gave a brief summary of the work the Planning Commissioners completed in 2017, which then went before the City Council for consideration and adoption. The Commissioners final 2017 work schedule included the following:

- Review and update of Cashmere's Title-16 Subdivision Code
- Review and update of Cashmere's Title-17 Zoning Code
- Review Cashmere School Urban Growth Area expansion (No action)

The 2018 proposed Planning Commission program may include the following:

- Review and update of Cashmere's Comprehensive Plan (State required update June 30, 2019)
- Review of Cashmere's official Zoning Map (River Street-commercial zoning designation)

Council suggested the commission review allowing chickens and livestock in the city. Also, review of the setback and height requirements for buildings and looking at setting a maximum square footage for accessory buildings. Minimum lot size was discussed and how lot size affects density; when utilities are extended, growth happens.

Councilor Fletcher reported on the progress of the regional utility study. Councilor Fletcher, Mayor Gomes, Director Botello and Planning Commissioner Chris Carlson have been representing Cashmere on the committee. The preliminary draft report on the Wenatchee Valley Utility Consolidation Study is complete and will be sent to council and planning members to review and comment.

Councilor Fletcher commented that for Cashmere regionalization would not necessarily make a great difference and even if the City wanted to proceed, it would be a long-term process.

#### CRUNCH PAK WASTEWATER SERVICES AGREEMENT

The Crunch Pak Wastewater Services Agreement was updated to reflect current operations. Crunch Pak has already approved and signed the agreement.

MOVED by Councilor Fletcher and seconded by Councilor Scott to approve the Crunch Pak Wastewater Services Agreement. Motion carried.

#### 2018 ROAD PAVEMENT PRESERVATION PROJECT OPTIONS

The City requested bids for the 2018 Pavement Preservation project. The bid request was for chip seal pavement with an HMA commercial grade (asphalt) alternate bid. Director Botello requested Council approval for one of three options.

Option #1 is a 1-inch asphalt overlay on all six streets for \$117,080 requiring a budget amendment of \$27,080.

Option #2 is a 1-inch asphalt overlay on just five streets for \$96,780 requiring a budget amendment of \$6,780.

Option #3 is a 1 shot and 2 shot chip seal on all six streets for \$83,500, which would not require a budget amendment.

Director Botello recommended Option #1. The 1-inch asphalt overlay would give a structural component, smoother riding surface, less sweeping maintenance and last an additional 15 years longer than chip seal.

MOVED by Councilor Smith and seconded by Councilor Erickson to approve option #1 for the 2018 Pavement Preservation project. Motion carried.

#### PROGRESS REPORTS

Director Botello informed the council of the results of the bids for reroofing the Public Works building. A Small Works Project contract will be drafted and presented to council for approval at the next meeting.

#### EXECUTIVE SESSION - To Discuss Potential Litigation

Mayor Gomes closed the regular session at 7:35 p.m. to enter into an executive session to discuss potential litigation for approximately 10 minutes. No action will be taken when regular session resumes.

The Executive Session was extended for an additional 10 minutes. No public was present to inform.

Regular session reconvened at 7:54 p.m.

Mayor Gomes adjourned the meeting at 7:55 p.m.

Paint stripe City streets per the attached Exhibit "A" and the MUTCD.

This Agreement is made and entered into by and between the Washington State Department of Transportation. hereinafter the "WSDOT," and the above named governmental agency, hereinafter the "AGENCY."

WHEREAS, the AGENCY has requested and the WSDOT has agreed to perform certain work as described above.

NOW THEREFORE, pursuant to chapter 39.34 RCW, IT IS HEREBY AGREED AS FOLLOWS:

#### 1.0 **GENERAL**

- 1.1 The WSDOT agrees to perform the above described work, using state labor, equipment and materials, as requested by the AGENCY.
- 1.2 The AGENCY agrees, in consideration of the faithful performance of the above described work to be done by the WSDOT, to reimburse the WSDOT for the actual direct and related indirect costs of the work. Administrative Charges at current rate are considered part of indirect costs.


#### 2.0 **PAYMENT**

- 2.1 The estimated cost of the work is stated above. The AGENCY agrees to set aside funds for payment to the WSDOT in this amount.
- 2.2 The AGENCY agrees to pay the WSDOT for the work done within thirty (30) days from receipt of a WSDOT invoice, which shall include documentation supporting the work done.
- 2.3 If the AGENCY is a county or city, the AGENCY agrees that if it does not make payment as provided under the terms of this Agreement, the AGENCY authorizes the WSDOT to withhold and use as payment Motor Vehicle Fund monies credited or to be credited to the AGENCY.

2.4	The AGENCY agrees further that if payment is not made to the WSDOT within thirty (30) days from receipt of WSDOT's invoice, the WSDOT may charge late fees and/or interest in accordance with Washington States	: e
3.0 3.1	INCREASE IN COST The parties agree that the estimated cost of the work may be exceeded by up to 25%. In the event of such increased costs the parties agree to modify the estimated cost of work by written amendment, signed by both parties. WSDOT shall notify the AGENCY of increased costs as they become known.	
4.0 4.1	RIGHT OF ENTRY The AGENCY grants to the WSDOT a right of entry upon all land in which the AGENCY has interest for the purpose of accomplishing the work described above.	
5.0	<ul> <li>TERMINATION CLAUSE (Check the Appropriate Box Below)</li> <li>5.1 This Agreement will automatically terminate five (5) years after date of execution. This Agreement may be terminated by either party upon thirty (30) days advanced written notice to the other party. If the parties cannot reach a resolution, the parties agree that any legal action to enforce any right or obligation under this Agreement may only be brought in Thurston County Superior Court. The venue specified in this section sha not apply to any federal agency that is a party to this Agreement.	II

#### **Recommendation:**

Motion to select Central Washington Asphalt as the low bidder for the commercial HMA pavement preservation project, and approve budget amendment for \$27,080 and authorize Mayor Gomes to sign contract.

#### **CITY OF CASHMERE**

#### **Small Works Construction Contract**

#### **Project: 2018 Pavement Preservation Overlay Project**

THIS CONTRACT is entered into by and between the City of Cashmere, Washington (hereinafter the "City") and <u>Central Washington Asphalt, Inc.</u> (hereinafter the "Contractor"), sometimes each individually referred to herein as a "party" or collectively referred to herein as the "parties".

In consideration of the terms and conditions contained herein, the City and Contractor agree as follows:

#### I. WSDOT STANDARD SPECIFICATIONS

- A. Except as may be otherwise specifically provided in this Contract, the definitions of terms used in this Contract and the other provisions set forth in the Washing State Department of Transportation Standard Specifications for Road, Bridge, and Municipal Construction, 2016 Edition (hereinafter "2016 WSDOT Standard Specifications"), shall apply to the standard of construction of the Project Work by the Contractor and shall apply with respect to all other matters not otherwise specifically identified in this Contract.
- B. The City is the Contracting Agency.

#### II. PROJECT WORK, PAYMENT, GUARANTEE

- A. The Contractor shall perform all Work and furnish all tools, materials and equipment for the construction for the Project in accordance with and as described in the City Request for bid and the Contractor Proposal and all other plans and specifications on file with the City for the bid amount. The aforementioned documents are by this reference incorporated herein and made a part of this Contract. The bid amount is inclusive of all applicable taxes, including Washington State Sales taxes and is: \$117,080.
- B. The City shall pay the Contractor for performance of the Project Work according to the City Request for bid and the Contractor Proposal on file with the City.
- C. The Project Work shall start within \_\_\_\_\_30 \_\_\_ calendar days after execution of this Contract and the issuance of a notice to proceed by the City. The Project Work shall be completed within \_\_\_\_10 \_\_ calendar/working days from the date of issuance of the notice to proceed by the City.

- D. If the Project Work is not completed within the time specified, the Contractor agrees to pay the City liquidated damages in the sum specified in Section 1.08.9 of the 2016 WSDOT Standard Specifications for each and every working day that Project Work remains uncompleted.
- E. The Contractor shall provide and pay for all equipment and labor required to construct and complete the Project Work. The Contractor shall guarantee the completed Project Work and all components thereof for a period of one year following the Completion Date of the Project Work, except as may be otherwise specifically modified by the City in the City Request for bids, the plans, specification, or other Project Work documents.
- F. Contractor shall be responsible for all temporary functions associated with the Project Work, including but not limited to, lighting, wiring protection, hoisting, scaffolding, rigging, flaggers, drinking water, dust control, storage, ventilation, and heating.

#### III. PREVAILING WAGE REQUIREMENT

The contractor shall pay prevailing wages for all Project Work and shall comply with Chapters 39.12 and 49.28 RCW. Notice of intent to pay prevailing wages and prevailing wage rates for the Project must be posted for the benefit of workers. At the completion of the Project the Contractor and its subcontractors shall submit Affidavits of Wages Paid to the Department of Labor and Industries for certification. Final payment on the Contract shall be withheld until the City receives certification from the Department of Labor and Industries that prevailing wage requirement have been satisfied.

#### IV. CONTRACT BOND

The Contractor shall provide a Contract Bond, in a form acceptable to the City, for the faithful performance and payment of all its obligation under this Contract. The Contract Bond shall remain in effect for the repair and replacement of defective equipment, materials, and workmanship and payment of damages sustained by the City on account of any such defects, discovered within one (1) year after the Completion Date.

#### V. PERMITS AND TAXES

Contractor shall secure and pay for all permits, fees and licenses necessary for the performance of the Project Work. Contractor shall pay any and all applicable federal, state and municipal taxes, including sales taxes associated with performance of the Project Work.

#### VI. INDEMNIFICATION

Contractor shall defend, indemnify, and hold harmless the City, its elected officials, officers, employees, engineers, agents, and volunteers from and against all demands, claims, losses, injuries, damages, liabilities, suits, judgments, attorneys' fees and costs, and other expenses of any kind incurred by the City on account of, relating to, or arising out of Contractor's Work under this Contract, except to the extent such injuries or damages are caused by the negligence of the City.

#### VII. INSURANCE

- A. The Contractor shall procure and maintain for the duration of the Project Work, and for a period of three (3) years thereafter, insurance against claims for injuries to persons or damage to property which may arise from or in connection with the performance of the Project Work by the Contractor, its agents, representatives, employees, or subcontractors.
- B. Contractor's maintenance of insurance as required by this Contract shall not be construed to limit the liability of the Contractor to the coverage provided by such insurance, or otherwise limit the City's recourse to any remedy available at law or in equity.
- C. Contractor shall maintain insurance of the types described below:
  - Automobile Liability insurance covering all owned, non-owned, hired and leased vehicles. Coverage shall be written on Insurance Services Office (ISO) form CA 00 01 or a substitute form providing equivalent liability coverage.
  - 2. Commercial General Liability insurance shall be written on ISO occurrence form CG 00 01 and shall cover liability arising from premises, operations, , stop gap liability, independent contractors, products-completed operations, personal injury and advertising injury, an liability assumed under an insured contract. The Commercial General Liability insurance shall be endorsed to provide the Aggregate Per Project Endorsement ISO form CG 25 03 11 85. There shall be no endorsement or modification of the Commercial General Liability insurance fort liability arising from explosion, collapse or underground property damage. The City shall be named as an additional insured under the Contractor's Commercial General Liability insurance policy. The proof of insurance and identification of the City as an additional insured shall be provided on a form acceptable to the City.
- D. Contractor shall maintain the following minimum insurance limit:
  - 1. Automobile Liability insurance with a minimum combined single limit for bodily injury and property damage of \$1,000,000 per accident.

- 2. Commercial General Liability insurance shall be written with limits no less than \$1,000,000each occurrence, \$1,000,000 general aggregate and a \$1,000,000 products-completed operations aggregate limit.
- E. Insurance shall be placed with insurers acceptable to the City.

#### VIII. GENERAL PROVISIONS

- A. Venue for any legal action arising out of the existence of this Contract shall be in Chelan County Superior Court. Except as specifically provided otherwise herein, in any legal action commenced by either party to this Contract, each party shall pay its own attorney's fees and costs, regardless or the outcome.
- B. This Contract contains the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements or understandings between the parties with respect thereto. This Contract may be amended only by an agreement in writing signed by both parties.
- C. The effective date of this Contract shall be the date the Contract is approved and signed by the City Mayor.
- D. This Contract may be signed in counterparts, each of which shall be an original but all of which shall constitute one and the same document. Signatures transmitted be facsimile or PDF e-mail shall be deemed valid execution of this Contract, binding on the parties.

#### **CITY OF CASHMERE**

#### **Small Works Construction Contract**

#### Project: Public Works Building Re-Roof

THIS CONTRACT is entered into by and between the City of Cashmere, Washington (hereinafter the "City") and <u>JS VAIL, LLC dba M Vail Company (License #MVAILVC956QD)</u>, (hereinafter the "Contractor"), sometimes each individually referred to herein as a "party" or collectively referred to herein as the "parties".

In consideration of the terms and conditions contained herein, the City and Contractor agree as follows:

#### I. WSDOT STANDARD SPECIFICATIONS

- A. Except as may be otherwise specifically provided in this Contract, the definitions of terms used in this Contract and the other provisions set forth in the Washing State Department of Transportation Standard Specifications for Road, Bridge, and Municipal Construction, 2016 Edition (hereinafter "2016 WSDOT Standard Specifications"), shall apply to the standard of construction of the Project Work by the Contractor and shall apply with respect to all other matters not otherwise specifically identified in this Contract.
- B. The City is the Contracting Agency.

#### II. PROJECT WORK, PAYMENT, GUARANTEE

- A. The Contractor shall perform all Work and furnish all tools, materials and equipment for the construction for the Project in accordance with and as described in the City Request for bid and the Contractor Proposal and all other plans and specifications on file with the City for the bid amount. The aforementioned documents are by this reference incorporated herein and made a part of this Contract. The bid amount is inclusive of all applicable taxes, including Washington State Sales taxes and is: \$51,921.93.
- B. The City shall pay the Contractor for performance of the Project Work according to the City Request for bid and the Contractor Proposal on file with the City.
- C. The Project Work shall start within \_\_\_\_\_90 \_\_\_ calendar days after execution of this Contract and the issuance of a notice to proceed by the City. The Project Work shall be completed within \_\_\_\_15 \_\_ calendar/working days from the date of issuance of the notice to proceed by the City.

#### VI. INDEMNIFICATION

Contractor shall defend, indemnify, and hold harmless the City, its elected officials, officers, employees, engineers, agents, and volunteers from and against all demands, claims, losses, injuries, damages, liabilities, suits, judgments, attorneys' fees and costs, and other expenses of any kind incurred by the City on account of, relating to, or arising out of Contractor's Work under this Contract, except to the extent such injuries or damages are caused by the negligence of the City.

#### VII. INSURANCE

- A. The Contractor shall procure and maintain for the duration of the Project Work, and for a period of three (3) years thereafter, insurance against claims for injuries to persons or damage to property which may arise from or in connection with the performance of the Project Work by the Contractor, its agents, representatives, employees, or subcontractors.
- B. Contractor's maintenance of insurance as required by this Contract shall not be construed to limit the liability of the Contractor to the coverage provided by such insurance, or otherwise limit the City's recourse to any remedy available at law or in equity.
- C. Contractor shall maintain insurance of the types described below:
  - Automobile Liability insurance covering all owned, non-owned, hired and leased vehicles. Coverage shall be written on Insurance Services Office (ISO) form CA 00 01 or a substitute form providing equivalent liability coverage.
  - 2. Commercial General Liability insurance shall be written on ISO occurrence form CG 00 01 and shall cover liability arising from premises, operations, , stop gap liability, independent contractors, products-completed operations, personal injury and advertising injury, an liability assumed under an insured contract. The Commercial General Liability insurance shall be endorsed to provide the Aggregate Per Project Endorsement ISO form CG 25 03 11 85. There shall be no endorsement or modification of the Commercial General Liability insurance fort liability arising from explosion, collapse or underground property damage. The City shall be named as an additional insured under the Contractor's Commercial General Liability insurance policy. The proof of insurance and identification of the City as an additional insured shall be provided on a form acceptable to the City.
- D. Contractor shall maintain the following minimum insurance limit:
  - 1. Automobile Liability insurance with a minimum combined single limit for bodily injury and property damage of \$1,000,000 per accident.

- 2. Commercial General Liability insurance shall be written with limits no less than \$1,000,000each occurrence, \$1,000,000 general aggregate and a \$1,000,000 products-completed operations aggregate limit.
- E. Insurance shall be placed with insurers acceptable to the City.

#### **VIII. GENERAL PROVISIONS**

- A. Venue for any legal action arising out of the existence of this Contract shall be in Chelan County Superior Court. Except as specifically provided otherwise herein, in any legal action commenced by either party to this Contract, each party shall pay its own attorney's fees and costs, regardless or the outcome.
- B. This Contract contains the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements or understandings between the parties with respect thereto. This Contract may be amended only by an agreement in writing signed by both parties.
- C. The effective date of this Contract shall be the date the Contract is approved and signed by the City Mayor.
- D. This Contract may be signed in counterparts, each of which shall be an original but all of which shall constitute one and the same document. Signatures transmitted be facsimile or PDF e-mail shall be deemed valid execution of this Contract, binding on the parties.
