## RESOLUTION NO. 12-2017 SOLID WASTE INTERLOCAL AGREEMENT

On July 24, 2017 the City Council adopted Resolution No. 08-2017 authorizing the Mayor to execute the 2017 Interlocal Agreement for the County-Wide Solid and Hazardous Waste Program. After approval and execution, the County revised Sections 11.6 and 11.7 and has requested the City's approval on the revised Interlocal Agreement.

## LEASE AGREEMENT FOR STORAGE AND OFFICE FACILITIES

The proposed Lease Agreement for Storage and Office Facilities has been revised to show the corrected amount to be collected in 2018 as \$34,687.65.

MOVED by Councilor Erickson and seconded by Councilor Fletcher to approve the Lease Agreement for Storage and Office Facilities for 2018-2022. Motion carried.

## AMENDMENT TO THE REGIONAL JUSTICE CENTER INMATE HOUSING AGREEMENT

The 2018 Chelan County Regional Justice Center bed rental rate will be increased to \$96.00 January 1, 2018. The period for the three-year average has been changed to run from July 2014 to June 2017 for the 2018 agreement.

The per day bed rate in 2015 was \$73.50, it was increased to \$85.00 in 2016, \$87.00 in 2017, and to \$96.00 starting 2018. The Chelan County Regional Justice Center will be using the Seattle, Tacoma, and Bremerton CPI-U as a factor to adjust the bed rate for 2019.

MOVED by Councilor Fletcher and seconded by Councilor Erickson to approve the Amendment to the Regional Justice Center Inmate Housing Agreement. Motion carried.

## **Staff Summary**

**RE:** Cashmere-Dryden Airport Sewer Charges

The Cashmere Dryden Airport was advised by the Chelan County Commissioners, after recommendations from County Legal, to pay the sewer charges.

The Airport is requesting City approval to pay the six years of back sewer charges over the next six years in annual installments.

The following language is from the Washington State Auditors Bars Manual for cities regarding Interfund Loans.

The term of the loan may continue over a period of more than one year, but must be "temporary" in the sense that no permanent diversion of the lending fund results from the failure to repay by the borrowing fund. A loan that continues longer than three years will be scrutinized for a permanent diversion of moneys.

After speaking with Mayor Gomes and referring to the language in the Bars Manual regarding City Interfund Loans we believe the time for paying the back-sewer charges should also be "temporary". The requested six years is an extended amount of time and could be considered loaning of public funds.

# Our recommendation is annual installments of \$5,523.84 over a three-year period beginning March 2018 through March 2020.

Airport says they will pay the current sewer charges after they receive the bill for December (bill for December is not mailed out until January 2<sup>nd</sup>). I would like to request that they pay the current outstanding balance by December 29<sup>th</sup> no later than 5:00 p.m. I have attached the account history.

## **Staff Recommendation:**

MOVED to approve the Airport paying the back-sewer charges in annual payments over a 3-year period as recommended by Mayor and Staff.
