## <u>PUBLIC HEARING FOR THE 6-YEAR TRANSPORTATION IMPROVEMENT PLAN</u> Mavor Gomes opened the public hearing at 6:06 p.m. Planning Director Mark Botello

Mayor Gomes opened the public hearing at 6:06 p.m. Planning Director Mark Botello summarized the items on the transportation plan.

Crunch Pak will pay half the cost of pedestrian-activated flashing lights on Sunset.

Future Chip Seal projects, continuation of the City-wide pavement preservation project: Chapel Street north of Pioneer to Angier Avenue and Glenn, Skyline, Valley View, Peshastin, Yakima, Phillips Place and S. Division St. in 2017.

Charlie Brown, 120 W. Pleasant asked for something to be done about his street. Brown handed out pictures of the deteriorating asphalt and potholes. He had to replace his tires and sway bar on his car due to driving through the holes daily. Director Botello stated the street could be repaved for about \$16,000 and that parking on one side only should be instated on W. Pleasant. The street is not a priority because there is not much traffic on the dead-end street. Mayor Gomes stated the TIP would be amended to include W. Pleasant in the future. In the meantime, the Public Works Department will fill the holes.

Rank Road widening is a large project scheduled for 2017.

Paul Sharpe, 116 W. Pleasant, asked how the priority of streets is determined and why water and sewer is a factor. Mayor Gomes informed him of the process and the cost of replacing water and sewer lines. Many times the City cannot afford to replace the lines, so streets that need water or sewer main replacement are postponed until the City can afford the replacement. We also look at maintenance, fire flow, capacity, etc. to determine if the lines need to be replaced.

With no further public comment the Mayor closed the public hearing at 6:27 p.m.

RESOLUTION 05-2016 SIX YEAR TRANSPORTATION IMPROVEMENT PLAN-2017 TO 2022 Moved by Councilor Erickson and seconded by Councilor Smith to approve the 6 year Transportation Improvement Program with the inclusion of West Pleasant and continuation of the City Wide Pavement Preservation program. Motion carried.

#### RH2 ENGINEERING TASK AUTHORIZATION #18 FOR RANK ROAD IMPROVEMENTS

The proposed change to the task authorization is due to required changes to the project after meeting with the residents. The major modifications include defining the curb line profile to accommodate tractors coming from the orchards, and designing closed drainage catch basins and a piping system for runoff. Cost of the change in engineering is \$9,900.

MOVED by Councilor Fletcher and seconded by Councilor Pratt to approve the RH2 Task Authorization #18 of the General Services Agreement for the Rank Road Improvement project and authorize Mayor Gomes to sign the documents. Motion carried.

#### ANNEXATION REQUEST FROM KEITH RANKIN FOR 5770 PIONEER AVENUE

Director Botello summarized the annexation request from Keith Rankin which consists of one property. Botello will send a letter to other residents of the area to see if they want to be included in the annexation. If they do, their property taxes will increase approximately \$100 per year, but they will save around \$700 annually in their wastewater bill since county residents pay 1.5 times the city rate.

After approval to proceed, Botello will draft the petition and set a public hearing for August 22. Moved by Councilor Fletcher and seconded by Councilor Erickson to accept the annexation request from Keith Rankin.

#### PROGRESS REPORTS

Director Mark Botello reported that a location for the charging station that will be paid by a grant has been agreed upon. The station will be right behind 101 Cottage Avenue. Power is available there and it is close to downtown. Botello stated that Joe Brown is unhappy that a parking stall close to his office will be used. Councilor Pratt suggested we consider putting the station at Riverside Park near the restrooms, since power is available there. Director Botello will look into it.



Since the completion of the Mission Ave improvement project a few years ago, the City has experienced water drainage issues with certain areas behind the sidewalk at the 300 block of Mission Ave.

The City utilized the Small Works Roster for this project, which is included with this staff report. The City received two bids from interested paving contractors. The contractors are Central Washington Asphalt and Mitchell Paving.

The two bids received are as follows:

Central Washington Asphalt:

\$19,854.70

Mitchell Paving:

\$20,511.69

This is a non-budgeted item, so this would need to be included in the budget amendment later this year. This was brought to staff's attention earlier this year; therefore was not included in the budget.

Staff will go over this in more detail at the Monday Council meeting.

Please see attached Ordinance No 1251 amending Sections 15.36.070 and 18.10E.070 of Cashmere Municipal Code to include references to the most recent flood insurance study. A few weeks ago the City had a Community Assistance Visit (CAV) from Ecology and the proposed amendments are required by them and need to be changed and adopted within 90 days to stay in compliance with FEMA insurance program. The proposed amendments are as follows:

#### 18.10E.070 Basis for establishing the areas of special flood hazard.

The areas of special flood hazard identified by the Federal Insurance Administration in a scientific and engineering report entitled "The Flood Insurance Study for the City of Cashmere" dated September 30, 2004 August 27, 2003, with accompanying flood insurance rate maps, and any revisions thereto, is adopted by reference and declared to be a part of this chapter. The Flood Insurance Study is on file at City Hall, 101 Woodring, Cashmere, Washington. The best available information for flood hazard area identification shall be the basis for regulation until a new FIRM is issued which incorporates the date utilized. (Ord. 1052 § 1, 2004; Ord. 1020 § 1, 2002).

#### 15.36.070 Basis for establishing the areas of special flood hazard.

The areas of special flood hazard identified by the Federal Insurance Administration in a scientific and engineering report entitled "The Flood Insurance Study for the City of Cashmere" dated September 30, 2004 December 1, 1977, with accompanying Flood Insurance Rate Maps, and any revisions thereto, is adopted by reference and declared to be a part of this chapter. The Flood Insurance Study is on file at City Hall, 101 Woodring, Cashmere, Washington. (Ord. 1225 § 1, 2013; Ord. 742 § 3.2, 1989).

### ORDINANCE NO. 1251

AN ORDINANCE OF THE CITY OF CASHMERE, WASHINGTON, AMENDING SECTIONS 15.36.070 AND 18.10E.070 OF THE CASHMERE MUNICIPAL CODE TO INCLUDE REFERENCES TO THE MOST RECENT FLOOD INSURANCE STUDY PREPARED BY THE FLOOD INSURANCE ADMINISTRATION; CONTAINING A SEVERABILITY PROVISION; AND SETTING AN EFFECTIVE DATE.

WHEREAS, City staff and representatives of the Washington State Department of Ecology ("DOE") conducted a review of the provisions set forth in Chapter 15.36 and Chapter 18.10 of the Cashmere Municipal Code (CMC) related to flood plan management and insurance requirements; and

WHEREAS, based upon their review, City and DOE staff determined that Section 15.36.070 CMC and Section 18.10E.070 CMC should be amended to reference the most current version of the Flood Insurance Study for the City of Cashmere, which was prepared by Flood Insurance Administration in 2004; and

WHEREAS, the City Council concurs in the recommendation of City staff and DOE consultants, and now desires to amend Section 15.36.070 CMC and Section 18.10E.070 CMC to include references to the most current version of the Flood Insurance Study; and

WHEREAS, the City Council reasonably believes that adoption of this Ordinance is in the best interest of the health, safety and welfare of citizens of the City; NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF CASHMERE, WASHINGTON DO ORDAIN AS FOLLOWS:

Section 15.36.070 of the Cashmere Municipal Code is hereby amended to read as follows:

15.36.070 Basis for establishing the areas of special flood hazard.

The areas of special flood hazard identified by the Federal Insurance Administration in a scientific and engineering report entitled "The Flood Insurance Study for the City of Cashmere" dated September 30, 2004, with accompanying Flood Insurance Rate Maps, and any revisions thereto, is adopted by reference and declared to be a part of this chapter. The Flood Insurance Study is on file at City Hall, 101 Woodring, Cashmere, Washington.

Section 2. Section 18.10E.070 of the Cashmere Municipal Code is hereby amended to read as follows:

18.10E.070 Basis for establishing the areas of special flood hazard.

The areas of special flood hazard identified by the Federal Insurance Administration in a scientific and engineering report entitled "The Flood Insurance Study for the City of Cashmere" dated September 30, 2004, with accompanying flood insurance rate maps, and any revisions thereto is adopted by reference and declared to be a part of this chapter. The Flood Insurance Study is on file at City Hall, 101 Woodring, Cashmere, Washington. The best available information for flood hazard area identification shall be the basis for regulation until a new FIRM is issued which incorporates the date utilized.

Section 3. If any section, sentence, clause or phrase of this Ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or the constitutionality of any other section, sentence, clause or phrase of this Ordinance.

Section 4. This Ordinance shall take effect and be in full force five (5) days after this Ordinance or a summary thereof consisting of the title is published.

The estimated cost for processing these applications is as follows:

Additional fees associated with legal and engineering will need to be included. It is estimated that approximately another \$15,000 for legal and engineering.

Dear Mr. Gomes:

In June of this year, we contacted you about options regarding your pending applications for new water rights located within the Wenatchee River Basin in Chelan County. The effort to process water right applications was initiated in 2012 by the Chelan County Natural Resource Department (County) and local municipal water purveyors using the Coordinated Cost-Reimbursement Program (Program), as established by the Washington State Department of Ecology (Ecology) in RCW 90.03.265(3). In response to our letter, you indicated that you were:

- Interested in having your application processed under the program;
- Interested in understanding whether your application is eligible for participation in the program; and
- Interested in paying a processing fee in the range of \$5,000 to \$15,000 if your application qualifies for processing, subject to your final review.

Because you expressed interest in continuing with the Program in our last communication, this letter includes contracts for your review and signature to formally enroll in the Program. The enclosed contracts include the costs required to reimburse the County for administering the Program, the County's contractor for preparing your water right Report of Examination (ROE), and Ecology's review of the ROE and issuance of a permit. In order to participate in the Program, a signed contract and pre-payment of the permitting cost is required by September 30, 2016. Please return your signed contracts and check (made payable to Chelan County Natural Resource Department) in the enclosed, stamped envelope.

Water right permit applications will be processed in the order of their priority date, with the oldest applications processed first. Applicants who decline to participate or do not respond by September 30, 2016, will keep their applications on file with Ecology, but other Applicants will be processed ahead of them. Applicants returning signed contracts after September 30, 2016, may still be processed under the Program if water remains available.

We are working with Aspect Consulting, LLC (Aspect) to process water right permit applications under the Program. You may opt to hire your own contractor to provide the services listed in the contract; however, you will still be required to pay the base cost of processing the application to the County. The cost for your own contractor would be in addition to those paid to the County.
