3. Topics for joint meeting with City Council

Potential topics for the joint meeting include PROS plan, lagoon development, recreation coordinator position, where to generate growth while maintaining small town feel, promotion of tourism, generating business space and reopening the Angier Street bridge.

4. Parks, Recreation and Open Space (PROS) Plan

Commission members reviewed, commented and edited the draft survey. Comments mostly revolved around revising the survey so the information obtained is useful in determining the communities' current recreational uses and priorities for the existing and potential future parks and open spaces. Additionally, emphasis was reiterated to create pathways for the whole community to comment by generating a Spanish language version of the survey and specifically reaching out to the local businesses, chamber and schools.

The public meeting should incorporate interactive opportunities for people to express their thoughts and priorities that replicate the survey questions.
