# ORDINANCE NO. 1193 AMENDING THE 2011 BUDGET

The major amendment to the 2011 budget is combining the Cemetery fund and the Street fund into a Public Works fund. Other amendments include transferring capital savings for Riverside Center to the Capital Improvement fund and capital savings for a garbage truck to the Equipment Rental fund. Also, the Mission Avenue project was moved from the Public Works fund to the Capital Improvement fund and the transfers related to the project were removed.

MOVED by Councilor Fletcher and seconded by Councilor Wynne to adopt Ordinance No. 1193 amending the 2011 Budget. Motion carried.

# **EASEMENT FOR PRESSURIZED IRRIGATION LINE**

James DeLay requested an easement on the westerly boundary of the Treadwell-Brisky Cemetery property line to run irrigation to the six lots he owns. He plans to put in a pressurized system and the old line can't be used.

Director Botello explained that the City previously granted an easement in 1977. This new easement replaces and supersedes the old Deed of Easement previously recorded as No. 774985 on July 12, 1977.

MOVED by Councilor Fletcher and seconded by Councilor Knutsen to approve the new easement for a pressurized irrigation line located on the westerly boundary of the Treadwell-Brisky Cemetery. Motion carried.

## LETTER TO THE COUNTY REGARDING EVERGREEN SOUTH OF PIONEER AVENUE

Director of Planning/Building Mark Botello stated that Mr. Corbaley's house is located on Evergreen Drive on the south side of Pioneer Avenue, which is an undeveloped gravel roadway approximately 20 feet wide. The City has no plans to develop that portion of Evergreen Drive into a street and recommended the City approve the 25 foot front yard setback.

MOVED by Councilor Moore and seconded by Councilor Fletcher to authorize the Mayor to sign a letter stating that the City has no plans to develop the portion of Evergreen Drive south of Pioneer Avenue. Motion carried.

### PROGRESS REPORTS

Director of Operations Bob Schmidt reported that the Sunset Highway Bridge project is on schedule. The utilities and underground electrical is almost completed. There is a lot of progress being made that is not easily seen.
