ANNOUNCEMENTS & INFORMATION

Director of Planning Mark Botello gave the council members a copy of the draft Shoreline Master Program for their review. He informed them that a public hearing will be held on May 14, 2012 to discuss the draft and receive public comment.

Councilor Fletcher attended the Link Board meeting; he passed along the score cards for the council members to review. Link uses the score cards to show where they are in meeting their goals.

Mayor Gomes informed the council that he attended the Mayor's Summit which is put on by the Chelan PUD. Also, he informed the council that he has asked that the City of Cashmere be a part of the Wenatchee Valley Transportation Council (WVTC).
